**12pm: W. John Martin, MD, PhD** trained in Sydney, Australia, and subsequently pursued a pathology residency in the US, at the National Naval Medical Command, Bethesda, MD and further research training at Harvard University, Cambridge, MA; National Institutes of Health and US Food and Drug Administration (FDA). He holds Boards in both Anatomic and Clinical Pathology and Medical Microbiology and Immunopathology. In 1985, he was appointed Professor of Pathology with tenure to the University of Southern California School of Medicine where he identified cell damaging (cytopathic) "stealth-adapted viruses." These viruses were present in patients with various neuropsychiatric illnesses, including autism, and attention deficit in children, chronic fatigue and depression in adults and dementia in the elderly. Some of these viruses were originally derived from the monkeys used to produce live polio viral vaccines, but now pass readily between humans. In 1996 Dr. Martin founded "The Center for Complex Infectious Diseases" to pursue the role of stealth-adapted viruses in neuropsychiatric illnesses.
